FOR CONDUCTING VARIOUS ACADEMIC/CULTURAL/SPORTS ACTIVITIES  
IN THE PREMISES OF AEC SCHOOLS/JR. COLLEGE W.E.F. 01-06-2019

1. Use of School premises for commercial purpose will not normally be permitted.
2. Rates shall be 1.5 times of the above rates for the following categories :
  - a) Any other type of programme (other than academic, cultural/sports) conducted by Organization/Association of DAE employees
  - b) For use of employees and their families of all DAE units.
3. If the proposed utilization of school premises is for a purpose involving training of School/College students as the major beneficiaries, then a reduction of upto 25% on the electricity, rental charges etc. may be applicable on case to case basis which will be decided by AEES.
4. Damage, if any occurs to school premises/building, while using the school premises, the cost will be recovered from the Security Deposit.
5. In respect of an organization where facilities are being availed/extended on reciprocal basis, Chairman, AEES, is empowered either to reduce the user charges or waive partially/fully to such organization.
6. Wherever the user charges are to be refunded to the Organizations on cancellation of any scheduled programme after booking the school premises and after payment of user charges, it shall be examined by AEES/respective AEC Schools whether such user has utilized the school premises at least up to 90% of its booking during a financial year. If the school premises are utilized up to 90% of its booking, the request of user for refund of user charges for the scheduled programmes which could not be conducted can be considered.
7. No security deposit will be collected from unit of DAE for conducting official programme.
