Sub : Request Transfers of staff members of AEES for the Academic Year 2019-20 – reg.

This is in continuation of AEES circulars dated 08/11/2018 and 30/11/2018 inviting applications from the interested staff members who wish to apply for request transfer.

While compiling the applications, the following are observed:

- (i) some staff members who have come to their present place of posting on request transfer have once again submitted their application for request transfer without giving any specific reason, and
- (ii) some staff members who conveyed their unwillingness to join at their opted places on transfer during the academic year 2018-19, have once again applied for request transfer.

2. Before considering these applications, competent authority in AEES has decided to extend an opportunity to the staff members applied for request transfer that if any of them wish to withdraw their applications, they may do so latest by 25/02/2019; and the staff members who joined at their present place of posting on their request and have applied once again for a request transfer without giving the reasons need to submit the specific reason in writing latest by 25/02/2019. Staff members are advised to submit their requests in this regard through the proper channel only.

3. After compiling all such requests including the applications received against AEES circulars dated 08/11/2018 and 30/11/2018 and on receipt of the recommendations of the committee, the transfers will be ordered by AEES any time during the academic year 2019-20 subject to availability of vacancies in the relevant subject(s)/cadre(s). After ordering the transfer, if any staff member requests AEES for cancellation of the transfer order, the staff member concerned is required to bear the financial loss that would be incurred by the AEC School concerned for availing any services on ad-hoc/contract basis against his/her vacancy.

4. All Heads of AEC Schools/Junior Colleges are requested to circulate the contents of this letter to all the staff members who are working under their control and particularly to the staff who have applied for request transfer against the aforesaid circulars dated 08/11/2018 and 30/11/2019. It is also requested to display the copies of this official communication on the staff notice boards for information of the staff members so as to enable them to forward their requests to AEES within the specified period.

5. This issues with the approval of competent authority.
