**Sub: Forwarding of Pay fixation statement in terms  
of OM No. 10/02/2011-E.III/A dated 19/03/2012 of  
Department of Expenditure, Govt. of India**

Kind attention is invited to the OM No. 10/02/2011-E.III/A dated 19/03/2012 of Department of Expenditure, Ministry of Finance, Government of India wherein it has been decided that those Central Government employees who were due to get their annual increment between February to June during 2006 may be granted one increment on 01.01.2006 in the pre-revised pay scale as a one-time measure and thereafter will get the next increment in the revised pay structure on 01.07.2006 as per Rule 10 of CCS (RP) Rules 2008.

Accordingly, the pensioners of AEES who were on the rolls of AEES as on 01/01/2006 and whose date of next increment was due between February to June during 2006 have been granted one increment on 01.01.2006 in the pre-revised pay scale and their pay has been re-fixed as per the guidelines stipulated in OM dated 19/03/2012 and competent authority has approved their pay fixation. However, the said re-pay fixation needs an option in terms of Min. of Finance, Govt. of India OM No. 10/2/2011-E-III(A) dated 03/01/2013.

You are therefore requested to fill up the enclosed option form and forward the same to this office latest by 15/03/2013 for further necessary action at this end. On receipt of the duly filled in option form alone, the arrears of pay fixation will be released by AEES. The matter may kindly be expedited.
