Sub: Recognition of the Anushakti Central School and Junior College Teachers' Welfare Association (ACTSWA), Mumbai

Governing Council of AEES in its 154th meeting held in 16/03/2012 accorded approval to revise AEES (RA) Rules, 1987 on the analogy of Central Civil Services (Recognition of Service Association) Rules, 1993 with a direction to grant recognition to Associations subject to fulfillment of stipulated conditions in AEES (RSA) Rules, 2012. Accordingly, this office has framed Revised Rules for AEES employees and circulated vide letter No. AEES/F(6.22)/Vig./2012/3551 dated 22/06/2012 the Atomic Energy Education Society (Recognition of Service Association) Rules, 2012 to all the Heads of AEC Schools/ Jr. College with a request to display on the notice board and to circulate amongst the staff members working under their control.

2. After going through the said AEES (RSA) Rules, 2012 and in accordance with the provisions of Rule 4 of AEES (RSA) Rules, 2012, Shri P.S. Tanpure in the capacity of President, Anushakti Central School and Junior College Teachers' Welfare Association (ACTSWA) filed an application dated 26/07/2012 in the prescribed format seeking grant of recognition to '*distinct category*' of AEES employees.


3. Necessary documents have been furnished by the said Shri P.S. Tanpure in support of his claim that the said Anushakti Central School and Junior College Teachers' Welfare Association was duly registered with the Registrar of Societies, Mumbai under the Societies Registration Act, 1860 and under Bombay Public Trust Act, 1950. The said Shri Tanpure has also furnished the copies of amended Bye-laws and Memorandum of Association of ACTSWA vide his letter dated 27/01/2011 showing that the ACTSWA membership is restricted to a '*distinct category*'. The original membership forms and letter of authorization by each members were also furnished by the said Shri Tanpure vide his letters dated 05/05/2012 and 15/05/2012 which confirms that ACTSWA represents more than 35% of total membership of teaching staff of AEES.

4. After examining the aforesaid documents furnished by the said Shri P.S. Tanpure, it is observed that he has fulfilled the conditions stipulated in Rule 4 of AEES (RSA) Rules, 2012, for seeking recognition to a '*distinct category*' of teaching staff of AEES viz. ACTSWA.

Considering all these documents, competent authority directed to convey that the said Anushakti Central School and Junior College Teachers' Welfare Association (ACTSWA), a '*distinct category*' represents majority of teaching staff of AEES is hereby formally recognized by the Atomic Energy Education Society. Shri P.S. Tanpure, President, ACTSWA is however, informed that the continuation of grant of recognition to ACTSWA is subject to fulfillment of the conditions stipulated in Rules 5 to 7 of AEES (RSA) Rules,2012.
