Sub : Indulging in private tuitions by teachers of AEES – reg.

Reference is invited to AEES circular no. AEES/4(6)/VIG/2005/7194 dated 29.11.2005 (copy enclosed) reiterating that no teacher shall undertake private tuition which is in contravention of Rule 19 of AEES (Conduct) Rules, 2001. Even then complaints have been received in the Central Office that some of the teachers are indulging either in private tuition or conducting regular coaching classes outside AEES.

In view of the above, it may again be brought to the notice of all the teachers that they should not undertake private tuition and any teacher found to have violated these instructions will be liable for disciplinary action under CCS (CCA) Rules, 1965 as applicable to the employees of AEES.

The contents of this circular may be brought to the notice of all the teachers working in your school. It is also advised to display copies of the circulars on the notice board and staff room in order to give wide publicity among teachers.

Sub: Indulging in Private Tuitions by teachers of AEES.

Instances have been reported that some of the teachers of the Atomic Energy Education Society are indulging either in private tuition or conducting regular coaching classes outside AEES. This is in contravention of AEES(Conduct) Rules, 2001. In terms of Rule 19 of AEES (Conduct) Rules, 2001, " **No teacher shall undertake private tuition or private employment or otherwise engage himself in any business. Any teacher violating these instructions will be liable to disciplinary action under the CCS(CCA) Rules, 1965, as extended to the employees of the Atomic Energy Education Society.**"

Time and again, all the staff members were directed by AEES not to indulge in such activities. They were also informed of the consequences which may lead to their dismissal/termination from AEES service. Despite this, it came into light that some teachers are actively involved in taking private tuitions. This not only leads to deliberate dereliction of the legitimate orders of AEES but also acting in a manner of unbecoming of a teacher. Such acts amount to grave misconduct and attracts stringent action against them under CCS(CCA) Rules, 1965.

For the reasons stated above, it is once again reiterated that no teacher shall undertake private tuition and it is forbidden by AEES Conduct Rules. All the heads of AEC school/junior college are requested to draw the attention of all teachers to the contents of this circular for strict compliance in their own interest. Acknowledgement of all teachers be obtained having gone through the contents of this circular including those on leave for onward transmission to this office for record.
