2. 3. After last date of receipt of the representation, the case will be considered/examined and alteration/ modification/addition if required will be made in the Provisional Seniority List. Thereafter the Seniority List will be treated as final.

4. The Provisional Seniority Lists (Annexure 2 to 18) is also available on AEES website [www.aees.gov.in](http://www.aees.gov.in) under Recruitment Tab.

5. All Heads of AECS/JC and Section Heads of Central Office are requested:

(i) to circulate the Provisional Seniority List amongst the officials concerned working under their control and error/discrepancies, if any noticed, the same may be intimated to this office along with facts and figures after proper verification from the record within 30 days from the date of issue of this letter, if not it shall be construed that the particulars and seniority as assigned to these officials are correct.

(ii) to give wide publicity of the Provisional Seniority List and a copy of the same should be displayed on the "Notice Board" at a conspicuous place.

(iii) to take one copy of the Provisional Seniority List and the signature of the concerned staff should be taken having seen/checked all the details in the given Annexure and has found it to be correct. The said copy, duly signed by the concerned staff should be sent to this office for record. Any omission or error should be brought to the notice of this office.

(iv) that the representation so received from the officials for having any objections with regard to their seniority in their concerned grade/post, should be forwarded to this office **on or before 20/02/2026** at the latest. Any representation received after 20/02/2026 will not be entertained in any case and the seniority position assigned in the Provisional Seniority List will be treated as final. In case no representations are received, a 'Nil' report may please be sent and the seniority list shall be deemed to be final.

(v) Objections with regard to seniority already disposed of will not be entertained.
